# Winfield Township Supervisors Meeting Minutes of August 31, 2023

The regular monthly meeting of the Winfield Township Board of Supervisors was called to order by Chairman Matt Klabnik at 7:05 p.m. The other Supervisors present were Glenn Nagle and Mike Robb.

## **PUBLIC COMMENT PERIOD:**

There was no public comment.

### **MONTHLY:**

Mr. Nagle made a motion to approve the minutes from the July 27<sup>th</sup>, 2023, Supervisors' Meeting. Mr. Robb seconded the motion, with three yes votes, the motion carried.

**Guide Rail** – Mr. Klabnik made a motion to approve the advertisement for bids for guide rail on Stoney Hollow, Stargrille, Spiker and Bear Creek Roads. Mr. Nagle seconded the motion. All were in favor and the motion carried.

**Fall Road Tour** – Mr. Klabnik made a motion to approve and advertise the Fall Road Tour for October 31<sup>st</sup>, 2023, at

8:00am. Mr. Nagle seconded the motion. All were in favor and the motion carried.

**Budget Meeting** – Mr. Klabnik made a motion to approve and advertise the annual Budget Meeting for September 28<sup>th</sup>,

2023, at 5:30pm. Mr. Nagle seconded the motion. All were in favor and the motion carried.

Fall Safety Seminar – Mr. Klabnik made a motion to approve Township employees to attend BCATO's Annual Safety

Seminar on October 11th at the Herman Fire Hall for \$20.00 per person. Mr. Robb seconded the motion. All were in favor

and the motion carried.

Park Donation – Mr. Klabnik made a motion to approve accepting the donations of a bench from Mr. Furnace Filter, and

a picnic table from Carl Wiles to the Community Park. Mr. Robb seconded the motion. All were in favor and the motion

carried.

EMC - Mr. Klabnik made a motion to table to EMC discussion. Mr. Nagle seconded the motion. All were in favor and

the motion carried.

Road Department Report – Mr. Govan gave a road report including the mowing of the township and the Bicker and

Bear Creek Rd projects complete.
